

ORDINANCE NO. 11-16-2020

AN ORDINANCE OF THE TOWNSHIP OF WAYNE, CLINTON COUNTY, PENNSYLVANIA, REQUIRING BUSINESSES WITH A PHYSICAL LOCATION IN WAYNE TOWNSHIP TO OBTAIN A LICENSE; PROVIDING EXCEPTIONS FOR LICENSING AND PROVIDING PENALTIES FOR VIOLATION OF THIS ORDINANCE

BE IT ENACTED AND ORDAINED by the Board of Supervisors of Wayne Township, Clinton County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same, as follows:

1. Definition of Business: Any individual/individuals or organization/organizations with a physical location in Wayne Township engaged in commercial, industrial or professional activities for financial gain.
2. Business License: All businesses in Wayne Township, Clinton County, Pennsylvania, after the effective date of this Ordinance shall purchase a Wayne Township Business License and shall have that license available at all times within the business establishment. In the event that there is more than one (1) location within the Township, each location must obtain a separate license with the original to remain on the particular premises for which the license has been issued.
3. License Fee: A license fee of Twenty (\$20.00) Dollars shall be provided annually with license fees due on January 1 of each year and expiration of the license to occur on December 31 of the same year. The amount of the fee may be varied from time to time via Resolution of the Board of Supervisors.
4. Proration of License Fee: Should a business locate within the Township after June 1 of each year, the fee for that particular year shall be Ten (\$10.00) Dollars and expire on December 31 of that year.
5. Time Frame for Obtaining a License: A business which opens a physical location within the Township shall have forty-five (45) days from the date of commencement of operation to obtain a Business License and shall contact the Wayne Township Code Enforcement Officer for attainment of the license.
6. Application: Business License applications shall be on a form prepared by Wayne Township with the applicant fully completing all information required on the form.
7. Exceptions to Licensing Requirements: Any business involved solely in the manufacture/sale of farm or agricultural products, raised or grown within Wayne


Township, Clinton County, Pennsylvania, shall be exempt from obtaining a Business License as otherwise required herein.


8. Penalties: Any person/persons or organization/organizations conducting business as defined in this Ordinance within Wayne Township, Clinton County, Pennsylvania, who/which does not obtain an annual Business License shall be subject to a fine of not less than One Hundred (\$100.00) Dollars nor more than Five Hundred (\$500.00) Dollars, plus costs of prosecution and attorney's fees incurred by the Township in enforcement of this Ordinance.
9. Repealer: All Ordinances or parts of Ordinances, including Wayne Township Ordinance No. 62-1995, which are inconsistent herewith are hereby repealed.
10. Severability: If any sentence, clause, section or part of this Ordinance is for any reason is found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Board of Supervisors of Wayne Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
11. Effective Date: This Ordinance shall become effective on the earliest date provided by Township Law.


